What was that person's relationship to the child?	Relationship of the person with whom the child resided: <ul style="list-style-type: none"> <li>- the mother of the child if she has custody</li> <li>- the father of the child if he has custody</li> <li>- a person with whom a child resides and who stands in place of the child's mother or father</li> <li>- a person to whom custody of the child has been granted by a court of competent jurisdiction or by an agreement</li> </ul>
